Rijeka Doctoral Conference started as a biennial and turned into an annual international conference for doctoral candidates who wish to present and test their preliminary research findings before academics and practicing lawyers, as well as to discuss these findings with their peers. Speakers have to be enrolled in a doctorate study or a doctoral school, while the topics of their doctoral dissertation should be within the field of law or other field closely related to law.

Following the Conference, the RIDOC Books of Abstracts is published collecting summaries of the presented. While there are no conference proceedings, participants are encouraged to offer their papers for publication in the double-blind peer-review journal published by the Faculty of Law in Rijeka – [Collected Papers](#), which is indexed in HeinOnline, ECSCO, DOAJ, WoSS-ESCI etc. In addition to papers in Croatian, the journal accepts papers in English, German and Italian.
